Essential responsibilities

Clinical Practice

- Offer comprehensive Medical services, to those in need of it wherever necessary including at the home, or clinic setting.
- Assess client's functionality through House Calls to determine their difficulty leaving home based on Medicare requirements
- Take care of the sick and preserve and promote the health and wellbeing of those who are well.
- Focus on prevention and management of illnesses and their complications.
- Liaise with providers of all aspects of healthcare to ensure independence at home for patients, according to Medicare's design and stipulations.
- Provide research assistance and advice on all healthcare issues, answering questions that may arise either from interactions with our staff or from other healthcare providers.
- Ensure and promote functionality and serve as a safety net for patients who have their own personal physicians but have difficulty leaving their homes without interfering with the activities of their personal physicians unless upon request by patient or evidence that patients health is in jeopardy.
- Provide certification for all aspects of home care, including nursing and home maker/aid based on patient assessment.
